## ORDER

Before this Court is a verified Petition filed on September 25, 2025 by **OCTAGRAM NEWSWEEKLY PUBLISHING** represented by its Publisher- **ANTONIO A. Matter No. 01-1-07-SC, dated October 16, 2001, Re: Guidelines in the Accreditation of Newspaper and Periodicals seeking to Publish Judicial and Legal Notices and the Provisions of P.D. No. 1079, the petition is hereby GRANTED.

WHEREFORE, effective today, "**OCTAGRAM NEWSWEEKLY PUBLISHING**" is hereby accredited and authorized to participate in the weekly raffle of legal and judicial notices issued by this Court.




**ORDER**
