Cavite Job Fair connects hundreds to employment opportunities in Naic

Strengthening its commitment to employment generation and inclusive economic growth, the Provincial Government of Cavite, through the Office of the Provincial Public Employment Service Manager (OPPESM) led PESO Manager Rizalie P. Enero, successfully conducted a Job Fair on April 28 at Waltermart Naic.

In collaboration with the Local Government Unit of Naic and various employment partners, the activity opened doors to diverse career opportunities for Caviteño jobseekers by bringing together 36 participating companies, composed of 28 local employers and 8 overseas agencies.

The event served a total of 318 jobseekers, including 189 female and 129 male applicants, demonstrating strong public participation and highlighting the continuing need for accessible employment services within the

community.

A significant highlight of the activity was the successful hiring of 47 applicants who were hired on the spot (HOTS), providing immediate employment opportunities and reinforcing the effectiveness of government-led workforce development programs.

The presence and support of LGU Naic further strengthened the collaborative effort to

connect local talent with potential employers while promoting economic mobility for residents.

The successful job fair reflects the Provincial Government of Cavite's unwavering dedication to creating accessible pathways to employment, empowering jobseekers, and uplifting the lives of its constituents through responsive and people-centered public service. *(OPIO)*

The activity was led by Ms. Rizalie Enero, PESO Manager, in coordination with Ms. Fatima Carvajal, TUPAD Coordinator, and in partnership with the Department of Labor and Employment (DOLE).

During the

orientation, beneficiaries were briefed on the program's guidelines, scope of work, and proper implementation procedures to ensure orderly and effective participation.

A total of ten (10) beneficiaries will be engaged under the program for ten (10) days of community-based emergency employment.

Through this program, the Provincial Government of Cavite continues to strengthen its support for vulnerable and displaced workers by providing not only temporary income opportunities but also meaningful community service engagement. (OPIO)

Over 19k job openings in Calabarzon on Labor Day

Thousands of job opportunities are available for job seekers in the Calabarzon region as part of the 124th Labor Day celebration on May 1, the Department of Labor and Employment (DOLE) said.

Erwin Aquino, Regional Director of DOLE CALABARZON, said that a total of 19,390 job vacancies are available for job seekers in the region, to be offered across various sites in CALABARZON, bringing employment opportunities closer to the public, especially those seeking work.

"Ngayong Labor Day, magkakaroon ng malawakang job fair sa iba't ibang lugar sa Calabarzon. Libo-libong job opportunities ang inihanda [natin] mula sa daan-daang employers, parehong lokal at overseas," Aquino stated in an interview with the Philippine Information Agency.

A total of 174 employers participated in the celebration and are set to offer job opportunities across various sites in the region, ensuring that all provinces have access to equitable employment opportunities.

The schedule includes April 30 at the Imus City Sports Complex in Cavite; May 1 at the Jose Rizal Coliseum in Calamba City, Laguna; May 2 at Robinsons Place Lipa in Batangas and Robinsons Place Antipolo in Rizal; and May 6 at Tayabas City Hall in Quezon Province.

According to the 2025 data of the Philippine Statistics Authority (PSA), both the number of Filipinos seeking employment and those gaining jobs increased. However, the rise in job seekers led to a slight increase in the unemployment rate, which went up to 6.4 percent from 6.1 percent.

Aquino explained that this indicates increasing competition in the labor market, particularly among the youth and fresh graduates. Meanwhile, lower underemployment was recorded in the region, suggesting that more individuals are now engaged in stable and decent employment.

He added: "Sa kabuuan, lumalago ang labor market, pero kailangan palakasin ang job matching at skills training para mas maraming Pilipino ang makakuha ng angkop at



disenteng trabaho".

To address this challenge, the director stated that the Labor department is strengthening skills training and job-matching programs, as well as conducting job fairs in collaboration with other government agencies such as the Technical Education and Skills Development Authority (TESDA) and the private sector.

"Upang tugunan ang skills mismatch, aktibong nakikipagtulungan ang Department of Labor and Employment sa Technical Education and Skills Development Authority at iba pang ahensya. Pinapalakas [natin] ang mga training programs na nakaangkla sa pangangailangan ng

industriya," the DOLE director said.

Meanwhile, several government agencies, including TESDA, the Philippine Health Insurance Corporation (PhilHealth), the Social Security System (SSS), and the Pag-IBIG Fund, will extend services to Hire-On-The-Spot (HOTS) applicants and other job seekers requiring assistance.

This initiative promotes inclusive economic growth by expanding access to employment opportunities in local communities, in line with the government's commitment to provide "Disenteng Trabaho Para sa Lahat" for all Filipinos. (COP/PIA CALABARZON)

Pag-IBIG Fund Housing Fair opens doors to affordable homes under Expanded 4PH

More Filipino families will soon own new and affordable homes following the Pag-IBIG Fund's Housing Fair.

Last April 27, the South Luzon leg of the Pag-IBIG Housing Fair featured over 20,000 housing units from 50 developers accredited by Pag-IBIG and the Department of Human Settlements and Development (DHSUD). With its partner developers, the Housing Fair promised high-quality homes and subsidized rates as low as three percent (3%) under the Pambansang Pabahay Para sa Pamilyang Pilipino Program (4PH), the country's flagship program for subsidized homes.

Carlito Santiago Jr., a Pag-IBIG member for over 20 years, said the Housing Fair helped him find prospective developers that can help him find a new home for

his family after moving to the city.

For Santiago, owning a permanent home for his family is his top priority for his participation to the Housing Fair.

"Matagal na po akong naghahanap ng sariling bahay na matitirhan. Ang gusto ko po sana ay malapit lang sa Barangay Barandal, Calamba, Laguna. Matagal na rin kasi akong lumalaban sa bidding, pero hindi po ako nananalo dahil siguro sa edad ko at sa malaking monthly payment."

The Pag-IBIG Housing Fair included participating developers from all over South Luzon to ensure that every member and non-member can find prospective homes within their budget.

Couple Jenny and Ronnie Ustaris, both of whom have been Pag-IBIG members for 16 years, hoped to find discounted properties through the Housing Fair.



"Bihira lang kasi 'yung ganitong klaseng Fair kaya nagregister kami. Maraming choices at baka makamura. Ang hinahanap namin 'yung pasok sa aming budget at syempre yung location

kasi marami silang offer." In a press briefing, Domingo Jacinto, Vice President for Public and Member Relations Groups said the Expanded 4PH promises a home for every Filipino family by offering

affordable home for its members.

DSWD intensifies Pag-Abot Program in CALABARZON, expands reach to Cavite and Rizal

CARMONA CITY, Cavite (PIA) — The Department of Social Welfare and Development (DSWD) Field Office IV-A continues to intensify the implementation of its Pag-Abot Program across the CALABARZON region, expanding its reach in Cavite and Rizal to assist more families and individuals in street situations (FISS).

In Dasmariñas City, Cavite, 14 individuals and families were profiled in February 2026, with 11 voluntarily agreeing to receive immediate intervention. To further enhance service delivery, DSWD also opened its fourth Pag-Abot Program processing center in Cavite in March 2026, improving accessibility and response capacity in the region.

Meanwhile, in Rizal, the program continues to deliver positive results. In March 2025, five individuals in Cainta were successfully reintegrated with their families. In April 2026, 47 individuals and families from Antipolo City and Taytay participated in financial literacy sessions to strengthen their capacity for sustainable reintegration.

Further strengthening its outreach, DSWD Field Office IV-A conducted reach-out operations in Antipolo City on April 8, 2026, where 13 individuals from the barangays of Cupang, Dela Paz, and Mayamot voluntarily coordinated with the agency to transition away from street living.

The operation, conducted under the Pag-Abot Program, aims to provide appropriate interventions to individuals and families to help them achieve safer and more stable living conditions within their respective communities.

According to Christina Argayoso, Project Development Officer of DSWD Field Office IV-A, the individuals underwent documentation and assessment by the team and were successfully reunited with their families on the same day.

The agency also

continues to coordinate closely with barangay councils and city local governments to ensure proper monitoring and the delivery of necessary assistance to the individuals reached through the program.

Highlighting the human impact of the program, one beneficiary, "Kuya Emi" (not his real name), shared his experience after being reached by the DSWD in Antipolo City:

"Pagod na din ako sa pagpapalimos sa lansangan. Salamat at natagpuan n'yo ako 'dun."

According to DSWD, Kuya Emi and the other beneficiaries voluntarily joined the program and expressed willingness to cooperate with the agency in order to leave street life behind and start a safer, more stable life in their communities.

On April 16, 2026, they received livelihood assistance from DSWD. One of the beneficiaries,

Artemio, immediately used the financial support to establish a small frozen goods store—marking a fresh start away from the risks of street life, with guidance from the agency's social workers.

The intensified implementation of the Pag-Abot Program reflects DSWD Field Office IV-A's continuing commitment to reach individuals and families in street situations and support their journey toward stability and reintegration.

With strengthened coordination among local government units and sustained provision of essential services, the agency reaffirms its goal of helping vulnerable sectors rebuild their lives with dignity, safety, and opportunity—ensuring that no one is left behind in the path toward inclusive social protection and development. DA rolls out cash aid to farmers, fisherfolk in Bataan's 3rd district



The Department of Agriculture (DA) distributed cash assistance to farmers and fisherfolk in Bataan's 3rd district under the Presidential Assistance for Farmers and Fisherfolk Program (PAFFP).

It covered beneficiaries from the municipalities of Bagac, Dinalupihan, Morong, and Mariveles, as part of the national government's initiative to provide immediate financial support to more than 4.17 million farmers and fisherfolk nationwide through a P10-billion fund.

According to the DA Regional Field Office 3, qualified beneficiaries include farmers and fisherfolk registered in the Registry System for Basic Sectors in Agriculture (RSBSA).

Rice farmers must be cultivating not more than two hectares of land, while corn and sugarcane farmers must also be listed in the registry.

Fisherfolk, on the other hand, must be registered under the RSBSA-BoatR to qualify for the assistance.

Each eligible beneficiary received P2,325 to help offset rising production costs, particularly the increase in fuel prices that continues to affect the agriculture and fisheries sectors.

The PAFFP aims to provide immediate relief to farmers and fisherfolk as they cope with production challenges while supporting efforts to sustain food production and rural livelihoods. (CLJD/RPQ, PIA Region 3-Bataan)
