1st Agriculture and Fishery Provincial Forum strengthens support for Cavite farmers and fisherfolk



The Provincial Government of Cavite, through the Office of the Provincial Agriculturist headed by Engr. Anna Pamela Nova-Cruz, successfully conducted the 1st Agriculture and Fishery Provincial Forum with the theme, “Sama-samang Paghabi ng Kabuhayan at Kaunlaran para sa Magsasaka at Mangingisda ng Cavite,” on June 2, at the New Provincial Government Center in Trece Martires City.

The forum gathered farmers, fisherfolk, agricultural stakeholders, and representatives from various government and financial institutions to strengthen collaboration and provide information on programs and services aimed at improving the livelihood and productivity of Cavite’s agriculture and fisheries sectors.

Grand Ease of Doing Business Fair in Cavite delivers gov’t services to 1,700 clients

TAGAYTAY CITY, Cavite — Featuring services from 26 national government agencies, including those from the city government of Tagaytay, the Grand Ease of Doing Business (EODB) Fair underscored the vital role of citizen participation in improving public services.

Led by the Anti-Red Tape Authority (ARTA), the Grand EODB Fair last May 28 gathered various national government agencies to provide essential services, including license renewals to registration, official registrations, and e-government services to over 1,780 clients.

Chrishnalyn Castro travelled all the way from Isabela to renew her license from the Professional Regulation Commission (PRC) for the very first time at the EODB Fair.

“Very efficient and convenient. Napabilis ng registration for renewal. Napakasulit dahil galing pa kaming Isabela at pumunta kami dito para mag-renew ng aming ID.”

Josephine Basiño, a stay-at-home mom, also found the services carried by the EODB Fair incredibly convenient. Aside from bringing essential government services under one roof, Basiño also lauded for patiently answering her queries.

“Malinaw naman. Magaling silang mag-assist at sumagot. Less hassle lalo na sa mga busy mom na katulad ko. Malaking tulong na inilapit nila sa masa ang mga ito.”

Undersecretary Juabilly Racho, ARTA Deputy Director General, emphasized that working

closely constituents to improve public services delivery are key in driving job creation and access to business opportunities.

As the primary clients of government services, Racho urged the public to remain vigilant and report bureaucratic delays and excessive processes that prevent access to action.

DepEd readies IP schools for SY 2026-2027

The Department of Education (DepEd) is strengthening its IP Education (IPED) Program to close the digital and structural divide for Indigenous students, emphasizing that education in the Philippines remains inclusive.

In a press conference during the Oplan Balik Eskwela kick-off last June 4, DepEd CALABARZON Regional Director Carlito Rocafort said that schools under the IPED Program are given priority in key

programs such as the School Infrastructure and Computerization to address the digital and learning facility gaps in the region's last-mile and IP schools.

"Itong mga eskwelahan na ito, ito 'yung priority ngayon na mabigyan ng mga facilities and other infrastructure at mga computer na magagamit ng ating learners."

The IPED program, which caters to the specific cultural needs of IP learners, remains crucial in pushing

for holistic development and cultural preservation especially in public schools.

Currently, the region hosts 77 schools spread across seven division offices that are part of the IPED curriculum network based on the community's specific social and cultural context.

"Dito po sa Region 4-A, may mga IP group rin tayo. As for the implementation ng ating IP education, we have seven schools division offices."

According to the

Department of Social Welfare and Development (DSWD), the CALABARZON region is home to Dumaga, Aeta, and Sama-Bajau who are predominant in Rizal, Quezon, and Batangas provinces.

With schools reopening on June 8 for academic year 2026-2027, the CALABARZON region is expected to have around 3,867,516 learners across 6,018 schools. (PB-PIA CALABARZON)

DOLE Calabarzon launches biometric system to streamline TUPAD implementation

The Department of Labor and Employment (DOLE) CALABARZON has launched the TUPAD Biometrics Integrated Online System (BIOS), a digital platform designed to make the implementation of the Tulong Panghanapbuhay sa Ating Disadvantaged/ Displaced Workers (TUPAD) program faster, easier, and more efficient for both beneficiaries and implementers.

In a press release from DOLE Calabarzon, Regional Director Erwin Aquino said the launch of TUPAD BIOS represents another significant step in the agency's efforts to transform public service delivery through innovation and digitalization.

"The system strengthens beneficiary validation, improves monitoring mechanisms, minimizes duplication, and enhances program integrity," Aquino said.

He also emphasized that the innovation would help ensure government assistance reaches qualified beneficiaries efficiently while promoting transparency and accountability in program implementation.

Developed as a major innovation initiative of DOLE CALABARZON, TUPAD BIOS utilizes biometric technology to automate beneficiary verification, attendance monitoring, and records management.

The centralized platform

is expected to reduce manual paperwork, minimize encoding errors, prevent duplication of records, and strengthen monitoring mechanisms to ensure the integrity of the program.

The launch program featured an overview of the system, the unveiling of the official TUPAD BIOS logo, and a live demonstration involving TUPAD beneficiaries who experienced the biometric-based registration and validation process firsthand.

One of the TUPAD beneficiaries, Aileen Geli of Cabuyao City, Laguna, welcomed the innovation, citing its convenience and efficiency, as she shared her positive experience using the system.

"Napakabilis po ng proseso. Nakapag-register po kami agad at lumabas kaagad ang impormasyon namin sa system," Geli said.

TUPAD, one of the flagship emergency employment programs of DOLE, provides temporary wage employment to disadvantaged, displaced, and seasonal workers.

DOST-PAGASA Explains Connection Between Habagat, El Niño, and Heat Index Amid Changing Weather



As many areas continue to experience intense morning heat and sudden afternoon rains, the Department of Science and Technology Ilocos Region (DOST Ilocos Region) continues to step up its efforts to provide timely updates about the country's weather and climate. In response to many questions from the public after Episode 8 of Tekno PreSyensya, the agency hosted a follow-up discussion through Episode 10, titled “Bantay Ulat Panahon: Habagat-El Niño Outlook and Heat Index Monitoring.” The program featured Engr. Mark Louie A. Vergara, Weather Specialist II from DOST-PAGASA Northern Luzon, who cleared up confusion about current weather conditions and what to expect in the

coming months. Engr. Vergara explained that while the country's weather is currently normal, there is a 79% chance that a strong El Niño will develop between June and August, which could last until the early part of 2027. He corrected a common misunderstanding that the extreme heat we are feeling right now is already caused by El Niño. In fact, the start of El Niño is expected to bring more rain and stronger storms to the western part of the country first. This is because it pulls and strengthens the southwest monsoon (habagat), long before the actual dry weather and water shortage happen toward the end of the year. The discussion also focused on Tropical

Cyclone Jiangmi (locally named Domeng). While the storm is not expected to hit land, it is helping trigger the official start of the rainy season by pulling the habagat winds toward the country. This transition is the reason behind the sudden, heavy afternoon rains currently experienced in parts of the region, which are caused by localized thunderstorms that form after hours of intense morning and midday heat. The episode also broke down the concept of the heat index, or the “apparent temperature”—which is how hot the weather actually feels to the human body based on the air temperature and relative humidity (the amount of moisture in the air). When humidity is high, the body

struggles to sweat and cool itself down, making the air feel heavy and sticky. The agency warned that these conditions can cause severe stress to crop and farm animals and pose serious health risks like heat exhaustion and heat stroke, especially for outdoor workers like farmers, street sweepers, traffic enforcers, and construction workers. To stay safe at home, Engr. Vergara shared practical tips, advising residents to open windows on opposite sides of the house to create a natural breeze. He warned that running an electric fan inside a closed, unventilated room is unsafe because it only circulates the trapped hot air. The public was strongly urged to check DOST-PAGASA’s official

heat index forecasts regularly, and to immediately treat any signs of heat stress with proper rest, continuous hydration, and staying out of direct sunlight. “Mainit man o maulan sa gitna ng pabago-bagong panahon, ang pinakamahalaga ay ang pagkakaroon ng tamang impormasyon mula sa mga opisyal na mapagkukunan.
