Cavite Service Caravan holds 4th leg in Cavite City, expands access to government services

The Provincial Government of Cavite continued its commitment to bringing accessible and responsive public service closer to communities as the Cavite Service Caravan rolled out its fourth leg today, June 18, at the Montano Hall in Cavite City.

Led by Governor Abeng Remulla, the service caravan further strengthened the provincial government's dedication to inclusive and people-centered governance through the delivery of various frontline services directly to Caviteños.

The one-stop caravan gathered provincial offices, national government agencies, and partner organizations to provide a comprehensive range of programs and assistance aimed at addressing the immediate needs of residents, particularly those with limited access to government services.

Among the key services offered were free medical consultations, dental and oral health care, laboratory services such as ECG and fasting blood sugar tests, pharmacy assistance, and fluoride varnish application for children. Emergency medical support was likewise made available to ensure prompt response to health-related concerns.

Employment and livelihood opportunities were also highlighted

through job matching activities, career coaching sessions, and assistance from participating agencies including PhilHealth, TESDA, PSA, DTI, Pag-ibig Fund and Land Bank of the Philippines. Entrepreneurship support, cooperative assistance, and the promotion of local products through a trade fair formed part of the caravan.

Agricultural support services, including the distribution of vegetable seeds and seedlings, educational materials, and technical assistance for farmers and fisherfolk, were likewise extended during the activity.

Meanwhile, social welfare assistance, family planning counseling, legal aid services, and specialized support for persons with disabilities were made accessible to residents. Veterinary services such as anti-rabies vaccination, deworming, and free consultations for pets were also provided.

Digital literacy programs, internet connectivity services, and information dissemination booths further promoted awareness and accessibility of government programs among participants.

Joining Governor Remulla in the fourth leg of the caravan were Vice Governor Ram Revilla Bautista, and Board

As part of its Open Gov Week activities, DOST Ilocos Region facilitated an Open House event that welcomed students, partners, stakeholders, and the general public to learn more about the agency’s programs, projects, facilities, and science-based services. The activity featured interactive learning sessions such as Sci-Kwentuhan, SIMATAR, STARBOOKS, DOST Courseware, and STI Trivia, which made science, technology, and innovation more engaging and accessible to visitors. Participants also explored the SOLIDO DRRM Knowledge Hub, where they learned about science-based disaster risk reduction and management resources, and joined the Regional Standards and Testing

Laboratory tour (RSTL Tour), which provided a closer look at the technical services that support product quality, public safety, local enterprises, and evidence-based decision-making.

For DOST Ilocos Norte, the celebration was brought to Batac City through a series of activities led by Provincial Director Brian U. Rasco, including audiovisual orientations, interest profiling, a pre-election engagement for the Movement of Ilocos Norte DOST Scholars (MINDS), and the OneASIN-MMSU Salt Production Knowledge Sharing session. These activities highlighted the importance of public awareness, scholarship engagement, and knowledge-sharing in supporting education, local industries, and community development.

DOST Ilocos Sur, under the leadership of Provincial Director Jordan L. Abad, extended the spirit of open governance to Sto. The activity helped participants better understand how DOST’s technical assistance and equipment calibration services support public safety, quality assurance, industry competitiveness, and the needs of local enterprises.

Through Open Gov Week 2026, DOST Ilocos Region reaffirmed that open governance goes beyond opening doors—it is about building trust, encouraging participation, and making public service more accessible, responsive, and meaningful to the people. Trabaho Agad Job Fair opens doors to employment opportunities on Independence Day

In line with the celebration of the 128th Philippine Independence Day, the Department of Labor and Employment (DOLE), in collaboration with the Office of the Provincial Public Employment Service Manager (OPPEM) and the City Government of Dasmariñas, and various government and private sector partners, successfully conducted the Trabaho Agad Job Fair at SM City Dasmariñas on June 12.

The activity served as a platform to connect job seekers with prospective employers while bringing government services closer to the public. A total of 11,312 job vacancies were made available by 56 local companies and 4 overseas employers, offering diverse employment opportunities to job seekers across various industries.

The opening program was attended by City of Dasmariñas Mayor

Jennifer Austria-Barzaga, Vice Mayor Third Barzaga, DOLE CALABARZON Regional Director Atty. Erwin Aquino, DOLE Executive Assistant for External Affairs Gerald Dequina representing DOLE Secretary Francis Tolentino, 4th District Board Member Nickol Austria representing Governor Abeng Remulla, SM City Dasmariñas Mall Manager Editha Tayko, Provincial PESO Manager Rizalie P. Enero, City PESO Manager Jesuzaine B. Partoza, together with local officials, partner agencies, and stakeholders.

As part of the program, beneficiaries received assistance through various DOLE initiatives, including the Government Internship Program (GIP), DOLE Integrated Livelihood Program (DILP), and Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced Workers (TUPAD). Partner organizations were



likewise recognized for their invaluable contributions and continued support in advancing employment and livelihood programs within the province.

The ceremonial ribbon-cutting formally marked the opening of the job fair, symbolizing the shared commitment of

government agencies and partners in creating more opportunities for Caviteños.

The event drew an impressive 1,318 registered job applicants, with 397 applicants hired on the spot, highlighting the effectiveness of the job fair in providing immediate employment

opportunities and bridging the gap between employers and job seekers.

assistance in the coming weeks," Lim said.

Beyond immediate relief efforts, FFCCCII has earmarked an additional P5 million from its Welfare Fund for the possible repair and rehabilitation of public school buildings damaged by the earthquake, particularly those constructed under its long-running Operation: Barrio Schools program.

The combined emergency and rehabilitation commitment brings the total assistance package to P11 million.

Lim emphasized that helping fellow Filipinos during times of crisis has long been a core tradition of the Filipino-Chinese community.

"For centuries, the Filipino-Chinese community has stood side by side with our fellow Filipinos during times of calamity, crisis, and

hardship. We believe that helping others is not merely an obligation—it is a moral responsibility and a shared expression of our gratitude to the nation we proudly call home," he said.

He also expressed gratitude to the 30 member organizations of the Filipino at Tsino Magkaibigan Foundation whose generosity and cooperation made the relief effort possible.

The FFCCCII President called on Filipino-Chinese communities nationwide, member chambers, civic organizations, businesses, and private citizens to continue extending assistance to affected communities and support efforts to restore local economies in Mindanao.

"No act of kindness is too small when people are in need," Lim said. "The road to recovery may be long, but the resilience, courage, faith, and bayanihan spirit of the Filipino people remain

stronger than any earthquake."

The press conference coincided with the observance of the Dragon Boat Festival, one of the most important celebrations in Chinese culture. Lim noted that the festival honors Qu Yuan, a poet, patriot, and principled statesman whose devotion to public service continues to inspire generations.

"As we commemorate the Dragon Boat Festival—a celebration of patriotism, solidarity, and service to others—may we be reminded that our greatest strength lies in our unity and compassion for one another," Lim said.

World-Renowned Artist Hooranky Bae and Climate Change Task Force Sign Landmark Agreements for Global Climate Action and Sustainable Development

(MANILA, PHILIPPINES – May 2026) The Climate Change Task Force (CCTF), led by Director General Albert P. Dela Cruz, announced the successful signing of two landmark agreements with globally recognized South Korean artist BAE HAN-SUNG, professionally known as Hooranky Bae, marking a significant step toward strengthening international cooperation on climate action, environmental sustainability, and innovative climate financing.

The signing ceremony was held on May 21, 2026 at the Office of Commissioner Albert P. Dela Cruz of the Climate Change Commission. The parties formally executed a Memorandum of Understanding (MOU) for Strategic Collaboration on Climate Action, Environmental Fundraising, NFT Innovation, and Sustainable Eco-Agri Tourism Development, alongside a Digital Asset (NFT) Issuance and Climate Action Fund Project Cooperation Agreement.

The partnership establishes a comprehensive framework for integrating art, environmental advocacy, sustainable tourism, and blockchain technology to support climate-resilient development initiatives in the Philippines and internationally.

A central component of the collaboration is the



donation by Master Hooranky Bae of the rights to his internationally recognized masterpiece, "Flower of Water." This work, which holds a \$54 million valuation and is certified by the Korea Data Certification Authority (KDCA), represents a monumental contribution to the cause. The artwork and its associated NFT rights will serve as the financial and symbolic foundation for future environmental fundraising and climate action campaigns under the Ecosaver.Earth platform.

Through the application of fractional NFT minting technology developed by the Korean technical team, the initiative seeks to create a

transparent and innovative environmental financing mechanism. This allows the high-value masterpiece to be shared digitally, enabling global participation in climate action while supporting community-based sustainability programs.

In recognition of his contributions to environmental advocacy and international cooperation, the Climate Change Task Force formally conferred upon Master Hooranky Bae the title and credentials of "Climate Change Task Force (CCTF) International Ambassador." In this capacity, the artist will serve as a global advocate for climate resilience,

environmental stewardship, ecological conservation, and sustainable development initiatives.

The collaboration aligns with the principles of the United Nations Sustainable Development Goals (UN SDGs) and the United Nations Framework Convention on Climate Change (UNFCCC), promoting environmental integrity, transparency, community participation, and long-term climate resilience.

Priority projects under the partnership will support ecological conservation, climate adaptation, environmental rehabilitation, sustainable tourism, and community livelihood



initiatives in vulnerable areas of the Philippines, including Agno (Pangasinan), Tarlac, Palawan, Zambales, Pampanga, Camarines Norte, Camarines Sur, Mountain Province, Cagayan, Cebu, Surigao del Norte, Surigao del Sur, Agusan del Norte, and Agusan del Sur.

Prior to the signing, representatives of the Climate Change Task Force and Master Hooranky Bae met with local leaders in Agno, Pangasinan to discuss opportunities for strengthening local climate action initiatives and promoting sustainable eco-agri tourism development. The visit highlighted the growing role of arts and culture in advancing environmental awareness and community resilience.

Master Bae emphasized that art possesses the unique power to connect people across cultures and inspire collective action in addressing global environmental challenges. Through this partnership, he expressed his commitment to

supporting Philippine climate initiatives while promoting environmental stewardship through creative expression and technological innovation.

Director-General Albert P. Dela Cruz welcomed the partnership, stating, "This collaboration demonstrates how art, technology, and environmental leadership can work together to advance climate action and sustainable development. Master Hooranky Bae's contribution will help strengthen international support for climate resilience initiatives while creating meaningful opportunities for communities and ecosystems that need protection most."

The Climate Change Task Force and Master Hooranky Bae are expected to expand the initiative through strategic partnerships with international organizations, environmental institutions, philanthropic foundations, and private-sector stakeholders to accelerate climate action and sustainable development efforts worldwide.

Filipino-Chinese Groups Unite to Deliver P11 Million in Earthquake Assistance

MANILA, Philippines — June 19, 2026 — The Filipino-Chinese community, led by the Federation of Filipino-Chinese Chambers of Commerce and Industry, Inc. (FFCCCII) and the Filipino at Tsino Magkaibigan Foundation, has committed P11 million in emergency relief and rehabilitation assistance for communities devastated by the magnitude 7.8 earthquake that struck Mindanao on June 8, 2026.

Speaking during a press conference at the Federation Center in Binondo, Manila, FFCCCII President Victor Lim announced the community's immediate mobilization to support thousands of affected families, particularly in General Santos City and nearby areas.

"The Federation and the entire Filipino-Chinese community are deeply saddened by the devastation caused by this tragedy," Lim said. "Our hearts go out to the families who have lost loved ones, homes, livelihoods,

and sources of income. Nakikiramay po kami."

Immediately after the earthquake, FFCCCII's Regional Executive Director for Southern Mindanao, together with the South Cotabato Filipino-Chinese Chamber of Commerce, coordinated with the Department of Social Welfare and Development (DSWD) and local government authorities to assess the extent of the damage and identify urgent community needs.

Initial reports indicate that approximately 2,000 families in General Santos City have been affected, with assessments continuing in other impacted areas.

Recognizing the urgency of the situation, Lim convened an emergency meeting of leaders of the Filipino at Tsino Magkaibigan Foundation, an umbrella coalition of the 30 largest Filipino-Chinese civic, cultural, and business federations spearheaded by FFCCCII.

The coalition

immediately approved P6 million for emergency relief operations.

Of this amount, P1 million was immediately released through the South Cotabato Filipino-Chinese Chamber of Commerce to prepare and distribute relief packs for approximately 2,000 affected families.

Each relief package, valued at approximately P500, contains essential items including five kilograms of rice, canned sardines, noodles, instant coffee, and ten liters of drinking water.

In addition to food assistance, the Filipino-Chinese community is donating 4,000 galvanized iron roofing sheets to help displaced families repair damaged homes and begin rebuilding their lives.

"Our local chamber will continue to closely monitor developments on the ground and coordinate with government agencies to identify communities that may require additional
